Time Trials and Track Events

- 2026 Supplemental Regulations
 - SCCA requires supps for each event instead of one supp for entire season. Separate supps required for Time Trials and Track Day.
- TA/TD #1 – March 28-29
 - Sanctioned and registration open. Buying time from SFR for 2 groups, TD and TA. Both groups will have 2 – 20 minute sessions Saturday and 2 – 20 minute sessions on Sunday.
 - TA sessions from both days scored as one event best time from any of the four sessions will be scored for points. All TA drivers must have SCCA TT Driver license or equivalent. Limited to 35 drivers total.
 - TD sessions will include both TD Novice and TD Experienced. All novice drivers will have in-car coach or lead-follow instruction. Will release Novice drivers immediately following Experience group. Limit of 5 1st time Novice drivers and 25 total TD
 - Registration and Tech will open Saturday at 7:00am (Registration in Clubhouse and Tech in TA/TD Paddock)

 - Michael K. started creating marketing materials and posting.
 - Anthony needs to send latest March event flyer on Mailchimp
 - TBD Reno Event Dates
- Other 2026 Schedule – June 14 (Sunday) 2-Mile, Sept 12-13 2-Mile
 - May share time with another organization?
- Selling tow truck – Minimum \$5000. Ideally to TH for credit towards event costs?
 - Overall, having the truck did save money, but hard to find people to perform tow service. Truck is also aging.
 - Board majority approves sale of truck.
- Track Events Town Hall

 - No volunteers to assume Director position at this time
 - Michael K. assisting with Track Events marketing. Mark and Scott Cody assisting at Cars and Coffee event.
