## Financial Report

- Monthly reports
- Reimbursements/Expenditures
  - Pending – Web hosting to Cameron - \$53, one year
  - TRSS Expenses – Totaled to \$245.14
  - TA/TD #1 – SFR and Thunderhill Raceway checks cashed
  - Waiting for April 2026 invoice for Solo events from RPSTC

## Regional Business

- RallyCross
  - Met with Aron at Solo Round 1 event.
    - Checked dirt course behind RPSTC skidpad/grid. Too steep and rocks nearby.
    - Aron meeting with Minden Airport week after event to check on their dirt area.
- Hot August Nights
  - Decided not to pursue further due to need to find benefits.
- UNR FSAE (Nevada Electric Racing) Sponsorship
  - Learned a couple UNR freshman drive in our Solo Rounds 3-4 event
  - Board approved \$2500 “Gold” level sponsorship. Anthony to submit.
- Reno SCCA Apparel – Shirts101
  - Year-round store is online. Facebook post created.
  - Note from Region Development – Great Garage Gear is not longer an authorized SCCA licensee.
- May need a second driver for Solo van just in case.

- No new events planned at this time.

## Street Survival

- May 2 Recap
  - Only half the number of registrations from previous events (15 students)
    - Likely due to entry fee increasing from \$125-175.
    - Lack of advertising?
  - Limited number of coaches. Three coaches had two students.
  - Jason – Post-event survey? Carol says there is a form for after event.
    - Maybe send something two weeks after to see if learning was applied.

## Solo

- April 18-19 Events – Rounds 1-2 Recap
  - Mostly smooth event. One incident of car going off course into dirt. Car was able to drive after recovery. No damage to property. No injuries.
- May 9-10 Events – Rounds 3-4 Recap
  - Event went smooth. 74 drivers on Saturday. About 15-20 fewer drivers for Sunday.
- Board approves two Solo entry donations to Kiwani's (Scott Knauf; non-profit, bicycle donation/safety/repair)
- Potential Solo Sites
  - Squaw Valley – We were notified that Tahoe Palisades are concerned about tire marks and related damage to their parking lot and have declined site request.

## Time Trials and Track Events

- Thunderhill contract for 2026 events received.
- TA/TD #2 – June 14
  - Sanction approved. Registration open.
  - Michel has started marketing event.
  - 23 entries so far. Need double to break even (projected).
    - Being a Sunday event, not anticipating 60 entries...
- TA/TD #3-4 – Sept 12-13
  - Dave requesting feedback: If standalone event, Saturday standard 2-mile, Sunday 2-mile bypass
- SFR RE asked if Reno Region interested in participating in season finale event.
  - Two days of racing and third day of Enduro. All on three-mile East Course.
  - October 16-18
  - Panos – Three sessions in one day would be good. Two sessions per day for two days is too spread out.
  - Open-ended discussion for now. No deadline for answer yet.
