Financial Report

- April 2023 Financials Overview
- Made slightly too much money to do free tax filing. Brittany has resolved this.
- All April open invoices to SCCA resolved.
- Track
 - Infiniti shifter assembly not repaired net. Best way to repair is to buy a used one.
 Could cost \$150 to \$250 plus labor.
 - New sawzaw purchased (listed in General Supplies).
 - New tires and battery charger for Infiniti
- Currently does not show \$16.8k deposit for Thunderhill dates
 - Check written in 05/05

Regional Business

 - New logos must be approved by SCCA Nationals. They have department that reviews logos.

Solo

- Solo Rounds 3 and 4 May 6 and 7
 - Shortage of Solo Safety Stewards on May 6. Does Nationals have an online class schedule set up?
 - Events went smoothly with no incidents.
- New dates July 15-16, August 19-20, Sept 16-17, October 14-15
- Winnemucca Wildcard May 20-21
 - Hosted by Snake River Region SCCA
 - Winnemucca Municipal Airport
 - Registration open on MSR

Time Trials and Track Events

- Schedule updated to June 24-25, July 22, and Sept 9
 - Rental deposit paid \$16.8k. Total rental cost for season will be \$33.6k.
 - Originally alternating 2-mile and 2-mile bypass, but negative feedback from drivers likely to change it to all standard 2-mile.
 - Driver request to run course in CW direction, but unable as SCCA does not sanction for that direction.
 - Sanction submitted for June 24-25
- Need 58 two-day entries to break even
- Charging \$10 for use of overnight electricity to help offset cost for track rental cost
 - Track cost: \$200 per day (four pedestals)
- Not doing first-timer discount this year. Most organizations charge more for entry fees for instruction.
- Pace car and tow truck still at Willows
- Expenditures
 - New tires installed for Infiniti
 - Solar battery charger for Infiniti
 - New battery sawzaw
 - Registration for tow truck \$190
